## NOTICE OF PEOPLES HEALTHCARE BYLAW

### Healthcare Sovereignty

Issued by the Sovereign Peoples Assembly of Western Australia

1. LET IT BE KNOWN that the members of the Assembly have voted unanimously that 'We the People' have a free and God given sovereign right to to choose our health care treatment and therapies, outside of the harsh, hard hitting, often toxic, synthetic, chemical, reactive prescriptive pharmaceutical system, in place in our communities, our country and our world.

We the People claim our God given right to enjoy and benefit from new energy frequency quantum therapies such as Rife Frequency technology, Pulsed Electro Magnetic Field therapy, Med Bed technology and any other quantum healing technologies not mentioned or not yet available to us.

We claim our right to traditional therapies, such as Ayurveda, Naturopathy, Homeopathy, Herbalism, and any other traditional therapy not mentioned. Other therapies such as Shamanism and Reiki, plus restorative treatments such as Massage and Float Tank therapy and any other therapies not mentioned. These traditional and ancient therapies that have been proven to be successful in relieving symptoms and curing diseases, have stood the test of time, where pharmaceutical treatments have been seen to cause more symptoms, toxic adverse events and even death.

2. This Bylaw allows trained and experienced therapists to set up their own practices either from home or in a dedicated premises, either alone or in a group, to offer their particular modality of healing to the general community, regardless of government bodies, particularly the Therapeutic Goods Administration corporation, and to offer their services for a fee, trade or gift or any exchange arrangement they so choose.

3. THEREFORE, IT IS ORDERED by the Sovereign Peoples Assembly of Western Australia, as a voice and defender of the people of our community that all men and women of the community are free to participate in a healthcare sovereignty arrangement that benefits themselves, their families and their community. No-one is obligated to consent to, or comply with any alleged law that says otherwise, regardless of what alleged authority, or individual, claims to order or compel them, and the people are free to actively resist and ignore any relevant directive or measure by any means necessary without fear of legal consequence.

IT IS FURTHER ORDERED by the Assembly that any individual, official, body corporate or their agent that prevents the people from this healthcare sovereignty arrangement, or attempts to prevent people from participating, or makes threats against the people participating in a healthcare sovereignty arrangement, is taking part in criminal actions against the life, well-being and liberty of free men and women, and stands in violation of this Order. As one engaged in a crime, the offender is subject to penalties and imprisonment upon conviction by the Common Law Court of the Sovereign Peoples Assembly of Western Australia.

THIS ORDER IS ISSUED on the ninth day of October 2022 as a lawful Bylaw by the Sovereign Peoples Assembly of Western Australia, Common Law Assembly, and has the full effect and force of the Law.

All police and public authorities are expected and compelled by law to enforce this Bylaw or be charged with obstructing justice and democratic process.
