

Who is the ATO?

Imagine you are 18 again, you leave school and find a job, the employer asks you for your Tax File Number (TFN) so he/she can enter the number into the payroll program. You don't have a TFN as this is your first job ever. Employer or parents tell you go make an application to the ATO for your new TFN.

Use ATO form NAT1432. Fill in all the details and get to the Declaration to sign for the ATO to give a brand new TFN, but first, READ THE PRIVACY STATEMENT.

*The ATO is authorised by the Taxation Administration Act 1953 to **REQUEST** your tax file number (TFN).*

This means that the ATO does not have your tax file number, so WHERE is your tax file number???? We think we are applying to the ATO to create a new number for us, but they have just told us they don't have it, this means the ATO is not creating a TFN for you but REQUESTING it from another source. WHO has our TFN and what does it really mean???

It is not an offence not to provide your TFN

What? How can you provide your TFN to the ATO when you are asking them to give you a TFN for the very first time?????

However, if you do not provide your TFN, there may be a delay in processing this form.

Now your form is going to be delayed in processing because you did not give them something you don't have? the very thing you are asking them to give you!!!!



This is PROOF, by their own words, that the ATO is an agency, it is not a government entity as we think government is, but an agency, a **private** business, it has an ABN, which means it is a business, why would a

FREEDOM OF INFORMATION ACT (FOI Act)

We refer to letter of 27 December 2000 seeking access to documents which became a valid request under the FOI Act upon receipt of the \$30.00 application fee on 24 January 2001.

Your request asks for certified copies of the legal documents that evidence:

(i) the existence of the Australian Taxation Office


After taking all reasonable steps to locate the document(s) you wish to access we are satisfied that a document does not exist. Consequently we must refuse this part of your request in accordance with section 24A of the FOI Act.

(ii) that require you to pay income tax

The only document relevant to this part of your request is the Income Tax Assessment Act which is available for purchase from the Australian Government Info Shop. A document that is made available for purchase by members of the public under arrangements made by an agency is excluded from the operation of the FOI Act in accordance with paragraph 12(1)(c) of that Act. As arrangements have been made for the purchase of the legislation you request for access is not granted.

The decision not to grant access was taken by Ian Shaw APS 6, who is authorised to do so by the ATO Solicitor. If you are not satisfied with the decision you may wish to use the avenues of review outlined in the attached schedule.

Enclosed is a receipt for your \$30.00 application fee.

This FOI requests has asked for “a certified copies of legal documents that evidence;

1. The existence of the ATO, and
2. That require us to pay income tax

The ATO Solicitor has replied to the FOI, as they MUST do to a request with:

“we are satisfied that a document does not exist”

I think it is time we start asking some very serious questions.

All corporations are only responsible to it's shareholders, so maybe this is why our government is no longer listening to us. An employee cannot order it's employer to do anything, the employer order's it employees to do things.

Your ATO Tax File Number Declaration for your new job, you are declaring to the ATO that have moved to a new place of employment. Right? Or are you reporting to your EMPLOYER (ATO) that you are being paid by another company? The place you work is a tax collector for the ATO and you are an employee of the ATO or Government and they are no longer our servants but the other way around.

Why does the declaration have your new boss as the **PAYER** and not the employer?????

Why are the people in the USA issued an EIN (equivalent to our TFN). EIN is Employee Identification Number.

Tax file number declaration

Complete a *Tax file number declaration* so your payer can work out how much tax to withhold from payments they make to you.

The ATO has never given us a true meaning of the word income. They have instead, given us an order to **UNDERSTAND** WHAT **WE** MEAN BY INCOME. The ATO is not giving us a true meaning of the word but a meaning they want you to stand under (obey).

Blacks Law Dictionary 4th

UNDERSTAND. To know; to apprehend the meaning; to appreciate; as, to understand the nature and effect of an act

UNDERSTANDING. In the law of contracts. An agreement.

THIS IS A CONTRACT. Why don't they use the word comprehend (a knowing) instead of the word for contract and agreement, UNDER STAND; TO STAND UNDER, to obey the contract. The word Comprehend does not have a meaning in the Law Dictionary.

What is income?

Australia's taxation system relies heavily on personal income tax, so it is important to understand what we mean by income.

You can receive income as a result of working or from an investment. Income may not always be in the form of money – in some situations goods and services may be treated as income.

Assessable income

Assessable income is income that can be taxed, provided you earn enough to exceed your tax-free threshold. Examples of assessable income are:

- > salary and wages
- > tips, gratuities and other payments for your services
- > allowances for things like car, travel, clothing and laundry
- > interest from bank accounts
- > dividends and other income from investments
- > bonuses and overtime an employee receives
- > commission a salesperson receives
- > pensions
- > rent.

GROSS INCOME. The term may mean the "gross receipts" of a **business** before deduction or Expenditures

INCOME. The return in money from one's **business**, labor, or capital **invested**; gains, **profits**, or private revenue

LABOR. Work; toil; service. (The word is sometimes **construed** to mean service rendered or part played in production of wealth)

WAGES. A **compensation** given to a hired person for his or her services; the compensation agreed upon by a master to be paid to a servant, or any other person hired to do work or business for him.

REVENUE. Return, yield, as of land, profit, that which returns or comes back from an investment, the annual or periodical rents, profits, interest or issues of any species of property, real or personal, income.

INVEST. To loan money upon securities of a more or less permanent nature, or to place it in business ventures or real estate, or otherwise lay it out, so that it may produce a revenue or income.

Only a BUSINESS can earn INCOME. Income is time or capital invested for profit. When we are employees we do not invest anything to the business. We hire our time to the business and we are compensated by money called WAGES.

Small business owners **invest** labour and capital into their business. Most small business owners work for nothing for a long time before they can the business to turn a profit. But the small business will always pay an employee and pay wages. There is a huge difference here.

The ATO says 'income' is wages, salary, etc etc. They can **say** whatever they want, as can you and I, freedom of speech, but do we have to obey a government or it's privately contracted agent?

If a law dictionary (the dictionaries used to create the laws) states income is money received from investment, then why are we the people declaring our wages as income?

When we volunteer this information, we are asking the ATO to tax us. If you tell them you earn \$90,000 they will tax you on that amount.

The ATO is given a report and your tax money directly by your employer or payer. So why do we need to put in our own declaration when they already have our details?

Read again the words taken from the Black's Law Dictionary above and comprehend their true meanings.
