Condemnation of Corporate Police Treatment of Rod Culleton

The recent unprovoked assault of Rod Culleton by the Corporate Police on the 20th October, 2023, is an all too frequent example of the authoritarian and tyrannical culture routinely imposed on **Crown: We The People Of Superior Jurisdiction**. Reflect back on the past few years and you will undoubtedly recall many such examples.

The SPAWA Common Law Court, Crown Executive Orders and the Common Law Sheriffs condemn this action and recognise a **failure of Lawful Due Process**.

Corporate institutions are perpetrating unprecedented attacks against **Crown: We The People Of Superior Jurisdiction**, the very people it supposedly serves. This must stop and **Rule of Law: All Are Equal Before The Law** restored.

Common Law exists to protect **Crown: We The People Of Superior Jurisdiction** by ensuring **Lawful Due Process**. What can only be described as unrelenting persecution of Rod Culleton by a private legal system, further illustrates **failure of Lawful Due Process**. Furthermore, this is a civil matter, begging the question: Why were the Corporate Police even involved??

Rod was afforded **Lawful Due Process** under the 25th Terra Australis Grand Jury, 31st Aug 2023, where it was found by a jury of his peers, based on irrefutable documentary evidence, to have been defrauded of his property by “unclean hands”. That is to say, undisclosed third parties entered the contract thus making it **Null and Void**. It was only after a Grand Jury Order, that the Common Law Sheriffs were directed to serve said Order to the current occupiers, requiring them to vacate Rod Culleton’s property, thus fulfilling **Lawful Due Process**.

This most recent and excessive response by the Corporate Police; resulting in the arrest of Rod Culleton, is further example of **failure of Lawful Due Process**. The Corporate Police failed to conduct the most fundamental investigation surrounding the circumstances of the incident and acted on unsubstantiated claims. The result was at least 9 Corporate Police Officers forced entry into a private residence, caused property damage and arrested Rod. The Corporate Police then placed Rod in a Police paddy wagon, despite being fully aware that Rod was suffering a life threatening medical condition.

The Common Law Court in conjunction with the Terra Australis Grand Jury and the Common Sheriffs are here to protect the rights of **Crown: We The People Of Superior Jurisdiction** by ensuring:
